#### **COURSE DESCRIPTION**

Analysis of different types of communication relevant to aspects of Italian contemporary life.

The focus will be on language and cultural competence based on the analysis of several current issues in the Italian world as seen through contemporary literary texts such as poems, excerpts from a narrative text, business communication, music and media. Students, through a wide range of evidence, will explore some of the questions the material elicit. Cross-cultural comparisons will highlight the relevance of the Italian language and culture in the Canadian Context. Attention will be given to the pragmatic skills of the social language, reading and creative writing.

#### **COURSE OBJECTIVES**

Students should be able to understand the topic of discussion conducted slowly and clearly, in a standard spoken language, to guess the meaning of unknown words from the context, to follow the main points of extended discussion around them.

Students should be able to interact with the instructor and the other students, answering and asking questions, to express their point of view in a clear way, using appropriate vocabulary.

Students should be able to read and understand general and specific information in many kinds of texts on contemporary issues through skimming and scanning reading strategies and be able to summarize texts. Students should be able to identify the main conclusion in clearly written argumentative texts, to guess the meaning of unknown words from the context, to use a dictionary to confirm meaning.

# COURSE NOTES

- The course will be conducted in Italian.
- Tests will include:
  - Reading comprehension, summaries, short compositions and vocabulary.
- The final assignment will deal with a small research on a cultural topic.
- The final oral presentation will be on a topic chosen by students or chosen from a list of topics. Preparation begins early and support will be provided throughout the semester.
- In class participation comprises of students' partaking and actively contributing to in-class activities and conversations, and brief at home research assignments (*compiti*) to be discussed in class.
- Informal *compiti* will be returned with suggestions for improvement and an opportunity to re-write. In this case the student will receive a ✓+ (or ✓++ if the re-write is excellent) towards participation.

#### LATE ASSIGNMENTS AND MISSED TEST POLICY:

- Missed tests will be graded as an F unless it is a case of emergency in which case a doctor's note is required.
- The Final assignment must be submitted in a hard copy and on the due date. Late assignment will not be accepted.
- There will be no make-up times for Oral presentations.

#### ACADEMIC MISCONDUCT

- 1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:
- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test):
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

- 2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.
- 3. Other academic misconduct includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.
- 4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
