DESCRIPTION

This course is an exploration of some of the salient cultural and social phenomena of modern and contemporary Muslims Societies of the Middle East, as seen through the medium of film. Through the prism of a number of representative films made in the Arab world and Iran, along with relevant historical and theoretical readings, we will explore such themes as colonialism, gender, politics, power, and religion. Throughout the semester, we will watch a selection of films made in the Islamic Middle East (and one about the Middle East made in the West), and will study the cultural, social, and religious issues they highlight. To give you a broader background about the cultural environment, the films will be coupled with relevant readings.

OBJECTIVES

The ability to critically assess and analyze film, and to understand the various social and cultural issues it highlights.

OUTCOMES

Upon successful completion of the course, the students will have covered a number of representative films made in the Muslim Middle East, and will have a broad grasp of some of the most important social, cultural, and religious phenomena specific to the region, while also developing the ability to express themselves orally and in writing.

COURSE NOTES

I may not be able to respond to your emails on the same day. I likewise won't be checking my email after 5:00pm and on weekends.

During the semester, I will be providing lots of information about the course policies, readings, paper and exam guidelines – in class and in writing. In particular, I will be uploading detailed guidelines about my expectations for your exams and essays to D2L, and will be explaining them in class. **Before emailing me with a question**, therefore, *check if the answer is found in one of the guideline-sheets, on the syllabus, or in your class notes*. If it's already there, don't email me as I may not answer.

ACADEMIC MISCONDUCT

- 1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:
- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.



- 3. Other academic misconduct includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.
- 4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
