DESCRIPTION: This course aims to provide you with means to orient yourselves in the past and present culture of the German-speaking regions in Europe, with a focus on Germany. We will explore connections between the past and present through the concept of a 'memory site' refers to a significant element of a culture (such as a particular story, a landscape, an artifact, an idea, a practice) around which a lot of cultural meaning has accumulated over the centuries and which is still a key reference in defining this culture in the present.

After defining some key concepts and a general overview of the region's cultural history, we will discuss a different topic over the course of the three lectures every week. You will be provided with copies of or links to visual and textual materials to study for each week, often with questions to guide your reading/interpretation. It is essential that you carry out these tasks in preparation for each class, as they will serve as basis for class discussion.

We will focus on the art, literature, architecture, major historical developments and events. Topics include, but are not limited to: The Berlin Wall; Ostalgie (= cultural nostalgia for the former East Germany); The Bauhaus; The Holocaust in Film; Expressionism: The Birth of Modernity;

OBJECTIVES

The course aims to help you achieve the following **learning outcomes**. At the end of the course, you should

- have **general knowledge about the cultural history** of Germany and
- have **specific, in-depth knowledge of key memory sites/events** within that history.
- be aware **how and with what effects these memory sites interact with different historical contexts**, including the present, in German-speaking cultures.
- be able to **critically analyze the roles that cultural memory plays** in constructing pasts, traditions, and identities, as well as the political aspects of such constructions.

Academic misconduct

1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:

- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.

4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
