This is an advanced course in syntax consisting of an in-depth investigation into potential parallels between nominal and clausal projections. Specifically, we will explore the hypothesis that there is a parallel between CP and DP. A first angle involves observing clausal properties in the nominal domain, and the second angle is the opposite side, namely finding properties in the clause that are typically associated with nominals. The goal is to become familiar with a focused topic in syntactic theory as well as to develop the analytical and critical skills needed to carry out original research. The course will consist of lectures, student seminar presentations and discussion. Finally, students will report on their own research on one of the topics covered in the course.

However, unless noted otherwise in writing, students must write up their own answers for submission of the assignment. Failure to do so constitutes plagiarism.
